Introduction

The need for the Village Halls Sustainability Project was identified through the existing Village Hall Advisory Service provided by Humber and Wolds Rural Community Council (HWRCC). Statistics in 2002 showed that out of 240 Community Buildings:

- 100 pre dated World War 2
- 57% provided limited or no access for disabled people

In addition, implementation of part 3 the Disability Discrimination Act 1995 in October 2004, and an increasing political focus on environmental issues, rural Community Buildings would be expected to improve facilities to comply with new legislation.

Aims of the Project

The aims of the project were to help management committees of community buildings in the East Riding of Yorkshire, North Lincolnshire and North East Lincolnshire:

- Increase access into the building by complying with the Disability Discrimination Act 1995, thereby increasing the potential number of people being able to use the facilities; and
- Reduce running costs by increasing energy efficiency in the building


The project started on 1st January 2003 and was funded for three years by the Community Fund and The New Opportunities Fund, SEED programme, subsequently The Big Lottery Fund. In kind support was also given by HWRCC.

Evaluation Methodology

Evaluation of the project has been a continuous process throughout the three years, culminating in a formal assessment in November and December 2005. This has been done through feedback questionnaires following training events, verbal requests for comments and an evaluation questionnaire (appendix 1).

Summary

It is clear from the response from management committees that the help and support provided by the project was needed. Implementation of the recommendations to improve accessibility and energy efficiency will take time as the process of applying for permissions and grants is lengthy and therefore the tangible benefits will not be seen for a few years.



The most popular way management committees contacted the project was by telephone (96) and the majority then went on to request an audit of their building (80). A full report detailing recommendations was produced for all buildings audited. A number of other halls were visited (15) and recommendations were discussed.

Training seminars attracted a number of committees (31) and a further number (25) attended other events where the project was represented. A full list of the Community Buildings and the type of help and support they received is included as Appendix 2.

Target set: 4 Mail shots to all 240 Village Halls


Achieved: 19 mailings



Evaluation Question

Where Management Committees Heard About the Project



Information Sheets covering Disability Access and Energy Efficiency for Community Buildings were included in the following eight issues of Humbrella. The Information Sheets were written and produced by the project officer. An article was also included in *Hallo!*, the bi-monthly newsletter for Village Hall Committees produced by the Village Hall Advisory Team at HWRCC and distributed with Humbrella.



Seminars and Workshops

Target set: Deliver 10 Energy Conservation seminars/workshops; 11 Disabled Facility seminars/workshops; 5 Combined Energy-Disability seminar/workshops;

Achieved: 4 Disability Seminars, 3 combined energy/disability seminars

Early in the project, it became evident from the number of requests received that one to one support in the form of a buildings audit and report was what the management committees wanted and needed. This was backed up by the poor response to Disability Access Seminars organised in 2003, and therefore efforts were concentrated on providing the building audits. However, the seminars that did take place were well attended.

The project officer was invited to speak about sustainable community buildings at the Yorkshire Rural Community Council Annual Conference in 2004 and to run a workshop at their 2005 Conference on Disability Access.


Site Visits

Target set: Conduct 75 Energy site visits and 75 Disability site visits

Achieved: 95 site visits completed

Visits to Community Buildings was deemed the most valuable way of giving benefit to committee members as recommendations specific to the building could be given.

Of the 95 sites visited, 80 received a full audit.



An audit entailed an assessment of the interior and exterior of the building together with information given by committee members present at the meeting.

Where an audit was not conducted, a set of Information Sheets was left with the committee members.

Comment from the evaluation:

"The visit to the hall was probably the most useful item gained from the scheme"

Bespoke Reports

Target set: Produce 64 bespoke reports

Achieved: 80 reports produced

A report detailing recommendations to increase disability access and reduce energy consumption was produced for all Community Buildings where a full audit was completed.

The report has proved a valuable tool for committee members to both prioritise work required and provide evidence of need when applying for grants.



Recommendations for Improvements Community Buildings



Energy Efficiency Measures

Target set: Evidence of reduction in energy use at 25 community buildings

Achieved: 9 buildings reporting measures taken, 28 in progress

The rising cost of energy prices has increased the outgoings of Community Buildings, sometimes resulting in an increased cost to the users. In order to keep the community facility a viable proposition, costs must be kept to a minimum.

In general, energy efficiency measures cost money to implement and therefore management committees will be looking to raise money, through local fundraising or grants. Finding tradesmen to provide quotations and recommend equipment suitable and applicable to the building is difficult. This combined means putting the measure in to place can take time. It is therefore expected the results of energy efficiency measures will be seen in years to come.

Comments from the evaluation:

"The overall comfort in the hall has increased"

"We can use the building in winter now!"

Case Study

Nafferton Village Hall had a high ceiling with no insulation and the main hall took a long time to heat up. The boiler was noisy and inefficient. For 30 years the committee had talked about installing an insulated suspended ceiling but had decided against it because badminton was played in the hall. When it became clear the boiler needed replacing and the cost of oil was increasing, they decided it was time to act.



To everyone's surprise, installing the suspended ceiling has not stopped badminton being played. Switching to gas, installing two boilers to provide heat to different parts of the building and siting the boilers above the stage have not only contributed to energy efficiency but has given the Village Hall some much needed room.

Evaluation Question

Have you considered renewable energy in your community building?

- Only 3 halls had considered solar electricity or hot water and 2 felt it could be an option for the long term.
- 33% felt it would be too expensive to install, 20% didn't know anything about it and 20% felt it was too complicated.

With the increasing focus on reduction of use of fossil fuels, renewable energy is an area that Community Buildings should be encouraged to explore in the future.

Disabled Access Measures

Target set: Evidence of improvements regarding disability issues in 25 community buildings

Achieved: 10 building reporting measures taken, 28 in progress

The implementation of part 3 of the Disability Discrimination Act 1995 in October 2004 had a direct effect on Community Buildings, who were then expected to provide facilities for disabled people. An existing building can be difficult to alter to incorporate, for example, ramps to entrances and accessible toilet cubicles. The project officer advised what was reasonable to expect of the committee, the users and the building in order to give easy access for all members of the community. Measures which assist partially sighted people, hearing impaired, mobility impaired and those with temporary injuries were also recommended, as well as those to assist wheelchair users.

Case Study

South Cave WI Hall is set up high from the road, with steps and a sloping concrete path to the front entrance. Internally, the hall is on two levels, with the toilets lower than the main hall. Local fundraising enabled them to replace the steps with a slope and a



handrail was added all along the path. The steps inside were replaced with a ramp and handrails and an existing toilet cubicle had grab rails added to create an accessible WC. These small things have made a lot of difference to the users, many of whom are elderly. The committee are pleased with the improvements, although they think they should have done it years ago it's made such a difference!

Comments from the evaluation:

“2 wheelchair users were pleased with the facility”

“Facilities are used by every user”

“People can get in and out of the building easily now”



An accessible toilet cubicle such as this one at Goxhill Memorial Hall can easily be used by wheelchair users and people with mobility impairments. It also has contrasting colours so the white ware is visible against the walls, a feature that partially sighted people find useful.

Perception of the Service

Overall the management committees found the service provided by the Village Halls Sustainability Project very good. Some management committees commented on the service provided by HWRCC, and again this was generally very good. A couple of areas for improvement were noted.


Evaluation Question

What is your opinion of the support/advice received?

- *6 respondents said “very good”*
- *3 respondents said “Excellent”*
- *2 respondents said the advice was “straight forward and clear”*
- *2 respondents said “very helpful and thorough”*
- *“Felt I had a hand to hold with difficult situations”*
- *“Advice was independent and impartial”*
- *“Staff team were extremely knowledgeable on subject”*
- *“Initial contact frustrating, possible for both parties. Once contact established, works well.”*
- *“Sometimes hard to reach due to meetings, phone not answered on Wednesdays or part time working”*
- *“Unclear of how HWRCC, Voluntary Action North Lincolnshire and North Lincolnshire Council work together”*

Further Support Requested

The number of Community Buildings reporting implementing the recommendations is lower than expected and therefore investigation into the reasons for this was required.



The process is lengthy because time is needed to obtain:

- Planning Permission
- Architects drawings
- 3 quotations to satisfy funders
- Community Consultation
- Decision from funders, which can take up to six months
- Local fundraising

As this process is completed by a voluntary management committee, who may lack skills, knowledge and time, it is unsurprising results are not seen for some period of time.

Evaluation Question

Would any of the following have helped you to put the advice and recommendations in to practice?

This indicates that the respondents would have benefited from a more dedicated 'hand holding' service. This could have resulted in more community buildings implementing the recommendations in a shorter period of time.

Conclusions

Overall, the project has achieved its aims and has reached, and in some cases, exceeded the targets set. The benefits to the rural communities are starting to be seen, and it is anticipated that it will take three years or longer for some of the committees to be in a position to make the alterations recommended.

A greater result may have been achieved if the project had included the scope for the project officer to be more involved with the process of implementing the recommendations. It has identified an additional specialist need to assist local communities identify suppliers, products and installers.

The report produced for management committee's following an audit of their community building has proved an invaluable tool for future planning and as evidence for grant applications. It is anticipated that the reports will continue to be referred to, particularly if the building requires any refurbishment in the future.

The ability to implement any improvements to a community building is highly dependent on the availability of grant funding. It is hoped that new funding streams will ensure management committees have access to the funding they require in order to provide a warm, comfortable, easy to use and safe community facility that is efficient and economical to run.
